Dear Chairman Paul and Ranking Member Peters:

September 8, 2026

The National Newspaper Association and PRINTING United Alliance appreciated the recent postal hearing held by the Homeland Security and Governmental Affairs Committee, and the bipartisan concern displayed. We write because, with respect, it is vitally important that you have the perspective of organizations that were fundamental to the creation of the USPS and its historic mission and are dependent on it and subject to its monopoly. Our concerns are rooted in USPS affordability, accountability and transparency, service and, perhaps most importantly, continuing its essential public service mission of delivering mail and packages to bind this nation together.

During the hearing, Chairman Paul identified five areas of inquiry as key to the examination of the USPS and its future. We therefore begin by responding to each as follows:

1. A real plan to bring labor costs under control.

Fundamentally, we believe that the Postal Service does not have a revenue problem; it has a cost and productivity problem. Workload and volume are way down, but headcount reduction has not remotely matched those declines.¹ And that is after many billions of dollars have been spent on automation, new facilities,² digital integration and more. That mismatch must be rectified, and other savings must be found. **A significant recent study shows that at just a 2% cost reduction per year; USPS would return to break even by 2030.**³

We are in extensive agreement with both of you that it is time for Congress to act, but not before the Postal Service: produces a plan to reduce labor and other costs; commits to greater use of public-private partnerships at the lowest combined cost; and suspends, at least temporarily, non-emergency capital spending, halting the Delivering for America Plan ("DFA"), which has failed. Careful consolidation of money-losing outlets balancing public and financial needs also makes great sense but would require a change in the law. And finally, review of the Universal Service Obligation should be a last resort; USPS must focus on its core mission.

2. Proof that private partners will be used where they cost less.

We believe that outsourcing of the Postal Service's "middle mile" would save billions of dollars, with jobs reduced via attrition. NNA publishers are prime examples of this arrangement. Our in-county papers are presented to the USPS at the facilities closest to their destination, pre-sorted and in carrier route sequence. Unfortunately, USPS does not measure our papers and fails to reflect this work in the rates our members are charged. The Postal Service has not done a study of the actual cost of handling local newspapers since shortly

after Congress passed the Postal Accountability and Enhancement Act. Its cost measurements are outdated and do not reflect the incredibly efficient mail that USPS handles for newspapers. Publishers sort their bundles by the direction of the carrier's delivery route, drop them into the post office's hands and provide such detailed delivery addressing that carriers have to do nothing but drop a copy in the mail recipient's mailbox.

Work-sharing provides opportunities to reduce costs, but the savings should be passed on to further incentivize its use and encourage more volume. There are other advantages.

- a. Combatting fraud via working with the private sector could add billions in savings.
- b. Fully utilizing private sector technological capabilities instead of trying to stand those capabilities up in-house would also save substantially.

3. A commitment to stop capital spending that shows no return.

The spending on capital improvements given the USPS's dire financial condition has been unwise and has not demonstrated benefits to quality service. It has also driven volume-killing unaffordable increases at an unprecedented twice-a-year cadence. The USPS should suspend non-emergency capital expenditures for at least two years, rigorously execute the hiring freeze recently implemented by USPS and focus on dynamic routing.

4. A willingness to consolidate facilities that no longer make sense.

Over the course of DFA, USPS slowed service twice. Because of that, no real apples-to-apples comparisons of service with pre-DFA can be made. And with the changes of RTO, found discriminatory against rural America by the PRC, the same is true within the DFA era. What our industry sees, every day, is that it is paying more for less, and that service can be inconsistent, late or even occasionally overlooked. And that all impacts consumers nationwide. Service must be improved and should be the lens through which facilities are considered.

5. And proof the service mandate can be met without permanent losses—and if it cannot, an honest debate about the mandate itself.

Because reducing service can diminish the value of the postal network and drive additional volume losses, it risks accelerating the self-reinforcing cycle of declining revenue thereby creating pressure for further service reductions. Such changes should only be considered after all other reforms have been exhausted and rigorous analysis demonstrates that they are necessary. In addition, there must be a mechanism to ensure that any theoretical savings actually occur. Diminishing service accomplished nothing except degrading demand for postal services if savings are not captured and used to keep postage affordable.

Beyond these areas of inquiry, we believe that there are additional categories that are crucial to be addressed in any potential legislation. They are:

Affordability. In light of \$30+ billion in losses over the past four years, it is no wonder that USPS has resorted to pushing the envelope on rates. The Postal Service, having raised prices anywhere from 50 to 100% or more, depending upon product, in just the last five years, is rapidly becoming unaffordable, especially for small businesses. And the mail is profitable: markups for First Class Mail range from 170 – 320%, and for Marketing Mail 160 – 180%.

Attempts to compare USPS prices to those of overseas administrations are fundamentally flawed and based on a false premise. At even 50% of the mail and packages of twenty years ago, the volume in the U.S. dwarfs that of any other nation. That enables efficiencies of scope and scale that other nations simply do not enjoy. Inordinately raising prices only pushes more volume out; volume that will not return.

Accountability and Transparency. From the perspective of the industry, it is imperative that the Postal Regulatory Commission ("PRC") not only be maintained but also strengthened. Since its inception in the Postal Reorganization Act of 1970, it has been the only expert, independent body that can hold the Postal Service accountable. It has been a

bulwark against rate exploitation or abuse.⁴ The PRC's necessity has been manifest in the case of the failed DFA. Developed in an insular manner within USPS, and with no discussions with its vast customer base, DFA created many problems that could have been headed off with consultations. We would refer the committee to the contents of H.R. 3004; The USPS SERVES US Act which NNA has endorsed and would modernize the PRC and ensure it can fulfill its critical role.

Merging the PRC with the Postal Board of Governors or simply eliminating it, respectfully, would not be a solution. The Governors adopted DFA, also not having consultations, individually or as a group, with stakeholders. The same was true with the Regional Transportation Optimization ("RTO") initiative. The PRC called out all the flaws in DFA and RTO in its advisory opinion of January 31, 2025.⁵ The contrast in accountability and transparency between the PRC and the Postal Governors is stark.

Service.

Public Service. As every Member of this Committee well understands, the postal system is a public service rooted in the Constitution. It performs minor heroics every day: providing prescriptions to veterans; delivering packages, newspapers, greeting cards, promotions and more valued by both senders and recipients; providing remittances to charities in need of funds to do good works and to businesses needing them to succeed. And it provides service to every American, wherever they may live, 6 days per week. The Postal Service's faithful execution of its public service mandate must be sustained.

Having said the foregoing, following is our response to recommendations from USPS management and others to this Committee to address the serious problems confronting and ensure continued delivery which is vital.

- Invest Postal Service retirement funds in a conservative private sector portfolio. Already done by Amtrak, the Tennessee Valley Authority and the Railroad Retirement Board, USPS returns would likely more than double annually and accumulate substantially over time, as noted by the USPS Inspector General.⁶ This provision is included in H.R. 3004 and is fully supported by our organizations.
- Return Civil Service Retirement System overpayments to USPS. Those overpayments have been a huge surcharge – effectively, a tax – upon customers diverted to non-postal purposes.
- Increasing the Postal Service debt limit Any increase must be accompanied by meaningful metrics in improving efficiency and productivity with authorities given to the PRC to hold USPS accountable to meet them.

We agree that it competes with digital messaging, but for anyone who chooses to communicate on paper, including those businesses required to by local, state or federal law, it very much retains not one monopoly, but two: over mail and over the mailbox.
