RE: Extension of Section 301 China Tariffs Exclusions

Dear Ambassador Tai:

On behalf of the undersigned members of Americans for Free Trade, we are writing to request that USTR provide an immediate extension for the limited China 301 [tariff exclusions](#) and [COVID exclusions](#), which are currently set to expire on September 30, less than 3 months from now. It is critical that USTR announce its plans – ideally a continuation of the existing exclusions – for these exclusions now so that companies can plan accordingly.

Our companies and associations joined together to form Americans for Free Trade in 2018. Our coalition represents every part of the U.S. economy including manufacturers, farmers and agribusinesses, retailers, technology companies, powersports, service suppliers, natural gas and oil companies, renewable energy companies, importers, exporters, and other supply chain stakeholders. Collectively, we employ tens of millions of Americans through our vast supply chains.

In the last five years, American importers, including members of our coalition, have paid more than [\\$183 billion](#) in section 301 tariffs on products imported from China. The product exclusions granted to date have provided limited relief for some companies over this time. However, USTR has yet to announce whether the current exclusions – which expire in less than 90 days – will be extended.

As USTR is fully aware, American businesses make their supply chain and sourcing decisions many months in advance of products arriving here in the U.S. Since the tariffs have been in place, exclusion extensions have been announced routinely at the last-minute – sometimes within mere days of the exclusions being set to expire. Such late announcements create planning issues for companies who made their sourcing decisions months in advance. Providing early extensions will provide certainty for American companies and help maintain their competitiveness – especially those who import products where there is no domestic or other sourcing alternative – as well as ensure continued access to life saving goods. Failure to provide early and timely information undermines the Administration's state goals of ensuring supply chain resiliency.

Any delay in announcements regarding the exclusions extension or expiration compels American companies to incorporate 25 percent price increases into product lines that may soon be without a Section 301 tariff exclusion. Upward pricing pressure of this kind will continue to exacerbate inflationary pressures on American companies and the U.S. economy. We therefore urge USTR to provide continued relief by promptly renewing all the exclusions which are set to expire in September.

We also renew our request for USTR to create a more robust exclusions process that is open to all products that are covered by the China 301 tariffs. As long as the Section 301 tariffs remain in place, there should be a fair, transparent, and robust exclusions process available so that American businesses can apply for targeted relief. We also call upon USTR to finalize the results of the four-year statutory review of the 301 tariffs. The comment period for the review closed over six months ago. Americans for Free Trade was one of hundreds of groups and companies who commented about the continuing negative impact of the tariffs and the need for a new strategic approach to address China's unfair trade practices.

American families, workers and businesses continue to face unprecedented and uncertain economic challenges, and we believe the administration should use every available tool to provide economic relief and predictability going forward. Renewing the tariff exclusions that are set to expire in a few months with ample notice, opening up a new and robust exclusions process for all covered products, and completing and announcing the results of the 4-year review will help provide that.
