Dear Mr. Chairman and Ranking Member Portman:

The postal business community recently offered its support for the Postal Service Reform Act, HR 3076, as is. We urge every Senator to vote “aye” on this critical, bipartisan legislation, approved in the House by an overwhelming 342 – 92 heavily bipartisan vote. But an even longer list of businesses writes again because it is vital that no amendments be accepted; any change will risk the broad bipartisan support this carefully crafted legislation enjoys.

In particular, some oppose repealing the unaffordable “prefunding” of postal retiree health benefits and requiring postal annuitants who have not yet subscribed to Medicare to do so, characterizing this as a “bailout” of USPS. Hardly a bailout, this financial correction is critical to the future of USPS, buttressed by important legal and equitable considerations, as well as ending USPS’ subsidizing Medicare. And some believe by codifying an integrated six-day delivery network, USPS will not have flexibility to adapt to changing conditions. Yet, the far larger risks lie in not maintaining a unified network, financially and operationally, a view that the Postmaster General endorses, and leaving the network open to complications in the annual appropriations process.

We also appreciate provisions in the bill that deal with rural newspaper sustainability, flats inefficiencies, the public performance dashboard and more.

We are all part of the huge postal-reliant industry – mail, packages and our supply chain -- which, in 2019, accounted for \$1.6 trillion in sales and more than 7 million jobs nationwide, but an industry under threat from problems confronting USPS. Your bill addresses critical parts of those problems effectively and appropriately.

So, on behalf of our industry, we want to thank you both and your staffs again for this very helpful legislation, and congratulate you on bringing it to this point.
